NOTIFICATION

Whereas, the draft of the following Rules further to amend the Karnataka Civil Services (General Recruitment) Rules, 1977, was published as required by clause (a) of sub-section (2) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), in Notification No. DPAR 142 SRR 2006, dated 20<sup>th</sup> August, 2007 in Part IV-A (No.1690) of the Karnataka Gazette Extra-ordinary dated 10<sup>th</sup> September, 2007 inviting objections and suggestions from persons likely to be affected thereby within fifteen days from the date of publication of draft in the Official Gazette.

Whereas, the said Gazette was made available to the public on 10<sup>th</sup> September, 2007.

And, whereas no objections and suggestions have been received by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka makes the following rules, namely:-

**RULES**

**1. Title and Commencement:-** (1) These rules may be called the Karnataka Civil Services (General-Recruitment) (67<sup>th</sup> Amendment) Rules, 2007.

(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of Rule 13:** In the Karnataka Civil Services (General Recruitment) Rules, 1977, in rule 13, in the first proviso after the words "the Category-1" the words "or Physically Handicapped" shall be inserted.
