NOTIFICATION

Whereas sub-rule 1A of rule 9 of the Karnataka Civil Services (General Recruitment) Rules, 1977 provides for three percent reservation (horizontal reservation) in recruitment for Group 'A' and 'B' posts for persons with disabilities;

Whereas as per Section 32 of the Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (Central Act 1 of 1995) (hereinafter referred to as the said Act), the State Government has to identify category of posts which can be reserved for persons with disabilities in Government Departments.

Whereas in exercise of the powers conferred by sub-section (1) of section 32 of the said Act and sub rule 1(A) of rule 9 of the Karnataka Civil Services (General Recruitment) Rules, 1977 the Government of Karnataka identified the posts for physically handicapped persons in Notification No. DPAR 104 SRR 2005, dated 13.9.2005.

Whereas as per clause (b) of Section 32 of the said Act, the State Government shall at periodical intervals not exceeding three years, review the list of posts identified and update the list taking into consideration the developments in technology.

Whereas in exercise of the powers conferred by sub-section (a) and (b) of section 32 of the said Act and sub-rule 1(A) of rule 9 of the Karnataka Civil Services (General Recruitment) Rules, 1977 the Government of Karnataka has reviewed the list of posts identified in Notification No. DPAR 21 SRR 2008, dated 3.8.2009.

Whereas the Hon'ble High Court of Karnataka in its interim order dated 2.8.2012 in Writ Petition No. 17942/2010 (GM-RES) – National Federation of the Blind Vs the State and in connected Writ Petitions has directed the State Government to adopt the list of Group-A and Group-B posts identified by the Central Government for persons with disability.

Now, therefore, in exercise of the powers conferred by sub-section (a) and (b) of section 32 of the said Act and sub-rule 1(A) of rule 9 of the Karnataka Civil Services (General Recruitment) Rules, 1977 the Government of Karnataka hereby mutatis mutandis adopts the Government of India Notification No. 16-70/2004-DD.III.

dated: 18-01-2007 for the purpose of reservation of posts of Group-A and Group-B as identified for each disability specified therein including the posts already identified by the State Government in the Notification No. DPAR 21 SRR 2008, dated: 3-8-2009. —

Provided that where the nomenclature of any post in the State Government is different from the post in Government of India or any post in the State Government does not exist in any department of the Government of India, the matter shall be referred to the Expert Committee constituted under the Chairmanship of the Principal Secretary to Government, Women and Child Development Department, Government of Karnataka. The Committee shall identify the equivalent post on the basis of nature of job and responsibility of each post.

The candidates shall produce the Medical Certificate issued by the Medical Board to the effect that their disability will not have any effect in the performance of their duties in the executive posts identified for Persons with Disabilities.
